WILLIAM HENRY DARBY of Leap Castle, M.A. Barrister-at-Law, born 1790; married first, Laura Charlotte, dtr of Ed. Jeremiah Curteis, Esq. of Windmill Hill, Sussex and by her (she died 27 March 1847) had issue, 1 son, Jonathan, J.P. born 25 June 1828, mrd. Sept 7. 1853 his cousin Caroline Curteis, dh. of John Graham Esq. of the Glens, Sussex, & died (before his father) 19 Sept 72, having had 3 sons & 4 dtrs. His eldest son Jonathan Charles thus became heir to his grand father.
